Advocacy Officer Role at IHRDA

The Advocacy Officer plays a vital role in the fulfilment of the IHRDA's vision and mission. As part of a team, he/she assists to develop and implement IHRDA's programme of work to advance the legal protection of international human rights through African human rights treaties through advocacy. The Advocacy Officer assists in all IHRDA's programme areas: legal advocacy, capacity building, research and publications, and strengthening the African human rights system.

IHRDA has been a trailblazer in litigation before the protection mechanisms of the African human rights system, having obtained a number of decisions in favour of victims, some of which have been ground-breaking. IHRDA remains the only institution with cases before all the major human rights protection mechanisms in Africa. In spite of this jurisprudential record, these successes are being negated by the persistent failure of respondent States

to comply with the decisions of the mechanisms. The non-implementation of decisions not only affects victims directly but also undermines the existence of and confidence that victims repose in these mechanisms. Consequently, to address this challenge, IHRDA has developed an internal strategy for implementation. Among others, the strategy aims to facilitate the mainstreaming of implementation into the case-development process from its beginning and sustained engagement with the relevant local partners and State institutions to ensure full implementation of decisions obtained. However, IHRDA recognises that its effective implementation requires a more vigorous approach to its roll-out by enhancing its human resource capacity in advocacy beyond its current legal expertise.

Specifically, the Advocacy Officer will lead IHRDA's work in mainstreaming advocacy and activities on implementation of decisions from the identification and development of cases through to post-decision phases of the litigation process. Further, the Advocacy Officer will lead IHRDA's work on other advocacy-related activities within its three-fold mandate of 'Defend', 'Educate' and 'Inform'. This work will be carried out across all African countries in which IHRDA is working, along with the subregional and regional mechanisms on the continent.

You are a highly motivated, competent and ethical lawyer with strong international human rights and litigation experience, and a commitment to high quality work and continuous learning. You are excited to elevate, redefine and shift the needle in human rights discourse and practice in Africa. You are highly adaptable and self-driven.
